To exhibit at Flood & Water Live 2023 please follow the steps below for your organisation:

1. View the site plans (Page 9-11) and stand options (Page 12-15) to choose which stand type(s) and where you would like to exhibit
2. Please read all supporting information in this Exhibitor & Sponsor Booking Pack including T&Cs, cancellation and payment terms
3. If you wish to discuss any aspect of the event or your stand options, do not hesitate to contact the Events Team (see Contact Us, Page 26)
4. Using the online Exhibitor Booking Form, please complete and submit your details, type and preferred location of stand including stand ID preferences (up to 3) and any other exhibition requirements (see page 18 for Online Exhibitor Booking Form link)
5. ADA anticipates a lot of interest in the event, so please note allocation of stands/plots will be made on a first come, first served basis. ADA kindly requests that you provide alternative choices of stand ID should your first choice have been booked
6. Following receipt of your Exhibitor Booking Form, you will be contacted by one of the Events Team within five working days, to confirm availability of your preferred stand and discuss any specific requirements outlined on your form
7. ADA will put your stand on reserve and issue an invoice to your organisation for a 25% non-refundable deposit. Payment will be required within ten working days of invoicing to secure your stand
8. When your deposit payment has been received, your booking will be secured and ADA will send you an email confirming your exhibition stand and the stand ID number
9. ADA will issue an invoice for the final balance of your stand fees on 1 April 2023 for payment within thirty days






LARGE OUTDOOR WORKING DEMONSTRATION PLOT

Plot Numbers: W01 to W30, W11 to W16 (See Site Plans Page 9-11)

Key details:

- Frontage of 100 metres and a depth of 6 metres.
- Exhibitors reserving one of these large working demonstration plots will also be allocated a large static plot on the main show site.
- Working plots W01 to W10 and W17 to W30 are along the watercourse and are ideal for boats, excavators, flail mowers and all weed cutting plant.
- Working plots W11 to W16 are raised embankments, but do not have access to water, and are ideal for the demonstration of smaller self-propelled grass cutting and robotic remote-controlled mowers.

Important information:

- Marquees, gazebos and exhibition trailers will not be allowed to be erected/parked near the working demonstration plots
- Plot location and allocations are identified on www.floodandwater.co.uk
- An identification plate will be affixed to each working plot
- Machinery must be positioned at the allotted plot by 18:30 on Tuesday 4 July 2023
- Machinery deliveries will not be allowed on the day of the event without prior agreement from the event organisers

- Any exhibitor wishing to allow third parties to operate their plant and equipment must ensure they are suitably qualified to do so and have held the appropriate certificates. Should third party operation result in an accident, the exhibitor will be held fully responsible

- Frontage of 30 metres and a depth of 20 metres.
- Outdoor grassed plots
- No services will be supplied
- Ideal for any plant, equipment or products

Important information:

- Marquees, gazebos and exhibition trailers will be allowed to be erected/parked within the static plot boundaries
- Plot location and allocations are identified on www.floodandwater.co.uk
- An identification plate will be affixed to each stand area
- Power will not be provided to static plots
- Use of generating equipment by exhibitors for the supply of electricity to static plots will be permitted
- Machinery must be positioned at the allotted plot by 18:30 on Tuesday 4 July 2023

SMALL OUTDOOR STATIC DEMONSTRATION PLOT

Plot Numbers: S02 & S19 (See Site Plan, Page 9-11)

Key details:

- There are 12 of these plots available within S02 and S19.
- Frontage of 8 metres and a depth of 4 metres
- Outdoor grassed plot
- No services will be supplied
- Suitable for service or product suppliers who do not require the full size of a larger outdoor static demonstration plot

Important information:

- Marquees, gazebos and exhibition trailers will be allowed to be erected/parked within the small static plot boundaries
- Plot location and allocations are identified on www.floodandwater.co.uk
- An identification plate will be affixed to each stand area
- Machinery must be positioned at the allotted plot by 18:30 on Tuesday 4 July 2023
- Machinery deliveries will not be allowed on the day of the event without prior agreement from the event organisers
- Power will not be provided to static plots

INDOOR EXHIBITION HALL (MARQUEE) STAND

Plot Numbers: EX01 to EX20 (See Site Plans, Page 9-11)

Key details:

- Frontage of 4.0 metres and a depth of 3.5 metres.
- Carpeted
- Overhead lighting
- Double 13-amp electricity socket

Important information:

- Exhibitors will not be permitted to run urns/kettles in the exhibition area as this will overload the generators.
- The use of generating equipment for the supply of electricity to stands will not be permitted
- Portable appliances, computing or similar equipment connected to the power supply must possess a current P.A.T. label, adhered to the appliance in accordance with current Health & Safety guidance
- Trade stands with their own internal wiring must comply with the 17th edition of the IEE wiring regulations BS7671:2008 and with the requirements of guidance note 7 (Special Locations) Chapter 12 (Exhibitions, Shows and Stands)
- Stands are provided without equipment, e.g. tables/chairs. If these are required contact the Event Team, at least one month ahead of the event (See Contact Us, Page 26)
- Shell schemes are not supplied and should be sourced independently if required but must be suitable to fit within a maximum area of 4.0m x 3.5m.
- Stand allocations are identified on the Site Plan on www.floodandwater.co.uk
- A stand ID plate will be affixed to each stand area
- Stand erection must be complete by 18:30 on Tuesday 4 July 2023
- Stand erection will not be allowed on the day of the event without prior agreement of the Event Manager (See Contact Us, Page 26)
- Exhibitors will not be allowed to sub-let or divide their space without permission from the event organisers

IMPORTANT EXHIBITOR BOOKING INFORMATION & REGULATIONS

INSURANCE

- It is the responsibility of the Exhibitor to insure all property, which is their own or for which they are responsible
- Exhibitors are required to provide Employers' Liability where this is required by statute
- Exhibitors are required to provide Public Liability Insurance with a minimum indemnity of £5 million to protect their liability

FORCE MAJEURE

If an event defined hereafter as Force Majeure occurs ADA will not be responsible for the financial consequences or any losses of any action claims or demands caused to or made by an exhibitor or their servants or agents caused by the failure of the Flood & Water Live 2023 Event to be held on one or more of the days but for the event of Force Majeure on which it would otherwise be held. Force Majeure means for the purposes of this clause exceptionally inclement weather; flooding of the whole or any part of the Show Site or the whole or any part of the car parks associated with it; an act of God including but not limited to fire, flood, earthquake, windstorm or other natural disaster; act of sovereign including but not limited to war, invasion, act of foreign enemies, hostilities (whether war be declared or not), civil war, rebellion, revolution, insurrection, military or usurped power or confiscation, nationalisation, requisition, destruction or damage to property by or under the order of any government or public or local authority or imposition of government sanction embargo or similar action: law, judgment, order, decree, embargo blockade, labour dispute including but not limited to strike, lockout or boycott; interruption or failure of utility service including but not limited to electric power, gas, water or telephone service; failure of the transportation or any personnel equipment, machinery supply or material required by ADA to run the Flood & Water Live 2023 Event; breach of contract by an essential personnel; any other matter or cause beyond the control of ADA. ADA recommends that all traders and exhibitors ensure adequate insurance is in place to cover all potential risks.

HEALTH & SAFETY

- Exhibitors will be required to adhere to all current Health, Safety and Welfare legislation
 - Exhibitors will be required to submit for approval Method Statements and Risk Assessments for all aspects of their planned participation in the event. These will cover as a minimum build-up of stands, break-down of stands, safety of personnel and visitors on stands during the event and operation of plant and equipment on the designated working demonstration plots
 - Exhibitors will be required to provide a stand layout plan with their Health and Safety documents, risk assessments etc. prior to the event
 - Further health and safety requirements will be issued within the final Exhibitor Information Pack
- Health and safety advice will be available on site throughout the event. If there are any concerns in this area or advice is needed, the Health and Safety representative should be contacted through ADA registration and event office in the main marquee.

IMPORTANT EXHIBITOR BOOKING INFORMATION & REGULATIONS

ARRIVAL & DELIVERY OF STAND EQUIPMENT

- The site will open for deliveries by exhibitors from 07:30 on 3 July 2023
- Requests for earlier deliveries of equipment must be sent to David Sisson, (see Contact Us, Page 26 for full details)
- Indoor exhibition marquee tent access will be available from 08:00 on 4 July 2023
- All plant and machinery will need to be on site and: parked at its allotted location by 18:30 on 4 July 2023
- There will be no deliveries permitted on site after 08:30 on the event days

PERSONAL PROTECTIVE EQUIPMENT

- During the set up and break down of exhibits, all persons working on the site will be required to wear hi-visibility jackets or vests
- The level of foot protection will be determined by exhibitors' risk assessments. It is expected that footwear worn for the set up and break down will vary from that worn during the exhibition when the risk is significantly reduced

UNLOADING

- The Event Organisers will prepare Traffic Management Plans prior to the event
- Exhibitors will need to refer and adhere to the HGV traffic management plan for Heavy Goods Vehicles on site movements and unloading
- Exhibitors will need to refer to and adhere to LGV traffic management plan for Light Goods Vehicles on site movements and unloading
- Special unloading requirements such as fork-lift trucks must be emailed to David Sisson, Event Manager prior to the event stating weight to be lifted
- Drivers of vehicles, plant and machinery must hold the relevant licence and be trained in the safe operation of the equipment. A copy of the licences will need to be sent to David Sisson, Event Manager with your Health & Safety documents
- The correct Personal Protective Equipment (e.g. gloves, industrial footwear, hi-visibility clothing) must be supplied and worn by all persons involved in the setting up of exhibits

NOISE

- Prohibition on any excessive noise between the hours of 22:00 and 07:00 the following morning. This will apply to all days of event through build up through to break down.

IMPORTANT EXHIBITOR BOOKING INFORMATION & REGULATIONS

MACHINERY, PLANT & EQUIPMENT

- All machinery should have fuel for the movements required to establish position on and off site
- Refuelling of vehicles onsite is prohibited
- Sharp points, spikes and sharp edges must be protected to prevent accidents
- Any equipment operated by hydraulics if demonstrated in an extended position must be suitably propped and at separate stages if in multi-stage rams

VEHICLE PARKING

- All exhibition tent and static plot exhibitors will park in the visitors' parking area and walk through to the exhibition area. The site will open from 06:30am on the event day
- HGV parking will be on the adjacent Dyson Farms Estate and will be detailed in the proposed HGV traffic management plan
- It is in the interest of visitor safety that no vehicle movements will be permitted onsite between the hours of 08:30 and 16:30 on the event days, apart from personnel carriers and support vehicles operated by the event organisers.

GROUND PENETRATION

- Ground penetrations or excavations are totally prohibited unless special permission is sought in advance of the event. This is to protect the fields under drainage system from damage and to avoid striking any unidentified underground services.

FIRE

- Exhibitors are required, at all times to have an appropriate inspected and in-date fire extinguisher prominently sited close by to electrical equipment and maintained in serviceable condition. Under no circumstances should water or water extinguishers be used on electrical fires or near electrical equipment

SECURITY

- Exhibitors will be responsible for the security of their exhibits. ADA will secure the services of a security company and cover the 'out of hours' period from Tuesday 4 July – Thursday 6 July 2023

IMPORTANT EXHIBITOR INFORMATION & REGULATIONS

SITE LAYOUT/STAND ALLOCATION

- ADA decision on site layout and stand allocation will be final and binding.

FOOD & DRINK ON STANDS

- Exhibitors are requested to advise ADA if they are receiving / hosting any VIP visitors to their stand during the event.
- The sale of food and drink on stands is prohibited. Hospitality for visitors, is permitted but must comply with relevant Food & Hygiene Regulations.
- Strictly no alcohol will be permitted on site.

FOOD OUTLETS & WATER SUPPLY

- On-site catering will be through approved food and drink purveyors yet to be procured.
- Fresh potable water will be available from stand-pipes in the Catering & Social Area of the site. Exhibitors should, as they specifically require, ensure that they have arrangements in place to transport water safely in purpose made carriers to their plot.

FIRST AID

- Exhibitors are asked to provide their own First Aid cover for the mobilisation and de-mobilisation periods, however St John Ambulance or similar approved supplier will be on site throughout the event days.

CAMPING

- Camping and overnight stays on the show ground or car parking areas are prohibited.

ALCOHOL ON SITE

- As a matter of safety, the consumption of alcohol is strictly prohibited on the Event Site and we respectfully ask that alcohol is not brought onto the site at any time.

SMOKING POLICY

- The exhibition tent will be a designated no smoking zone.

IMPORTANT EXHIBITOR INFORMATION & REGULATIONS

ANIMALS

- Prohibition of Animals on Event Site or Car Parking areas excepting Assistance/Guide Dogs. No animals to be left in parked vehicles

TOILETS

- Toilets will be provided and will be located in the Catering & Social Area of the site and at two locations central to the Working Demonstration plots

CLOSURE OF STANDS

- Exhibitors or their contractors may not close or dismantle any part of their stand before 16:30 on the final day of the show

CLEARANCE OF STANDS & REMOVAL OF WASTE MATERIALS

- All exhibition stands must be cleared from the site by 17:00 on 11 July 2023
- Ground should be fully cleared and all waste materials removed and stand area reinstated to original condition. Any failure to comply, will result in additional charges being levied on the stand holder by ADA

LITTER

- Exhibitors are responsible for cleaning their exhibit area. Bins will be provided which will be cleared by the organisers and disposed of in the main skip.

COVID-19

- We want our exhibitors, sponsors, visitors and contractors to be able to attend Flood & Water Live 2023 and feel confident that all necessary steps have been taken to reduce the risk posed by the Covid-19 virus.
- As organisers we will provide sanitizer stations positioned in the registration area and around the site.
- Anyone testing positive for Covid-19 or displaying symptoms should not attend the event.
- We will continue to monitor guidance from UK and local government and implement measures in accordance with the advice and update this information, closer to the event.
